Overview of the Piloting Event

On June 16 we conducted a piloting event on navigating AI in academia. The workshop attracted a full cohort of 35 participants, who comprised of both academic teachers and non-academic university staff, which reflected a widespread institutional interest in this critical subject.

Promotion for the event was conducted through our dedicated faculty social media channels, which highlighted the workshop's practical focus on the ethical integration of AI tools in higher education.

The session was facilitated by Dr. Piotr Sieniawski from the Institute of Political Science and Public Administration. Under his guidance, the workshop explained the complex landscape of artificial intelligence for the academic staff. He presented Guidelines on the use of AI Chat tools in higher education which was prepared by all partners in the project. A primary success was the clear explanation of the ethical standards that must be upheld when deploying AI within teaching and research, which provided a comprehensive framework for responsible use. The event was highly interactive, the audience actively raised challenging questions regarding the practical implementation of AI into their specific courses and administrative processes. Dr. Sieniawski skillfully addressed these concerns and turned potential challenges into valuable learning moments.

The direct benefit to participants was a significantly clarified understanding of how to harness Al's potential while rigorously maintaining academic integrity. The impact achieved is a more confident and equipped faculty, now better prepared to strategically and ethically incorporate Al advancements into their workflows. This will enhance both the quality and innovation of our academic programmes.

The piloting event gathered a diverse group of around 35 participants, aged between 30 and 60, who represented both genders and a variety of professional backgrounds. This composition reflected the project's target group, especially professionals engaged in higher education who are directly impacted by the growing integration of AI tools in teaching, research, and administration. The inclusion of both academic and non-academic staff ensured a comprehensive perspective on the challenges and opportunities that AI presents within an institutional context.

By focusing on the ethical and practical dimensions of artificial intelligence, the workshop addressed the specific needs of university professionals and helped them to understand how AI can enhance their work while maintaining academic integrity. The session not only strengthened participants' digital competencies but also fostered a shared institutional awareness of responsible AI use in academia.
